- Delivered mainly by school staff
- Impartial information, advice and guidance
- Delivered mainly by external guidance specialists

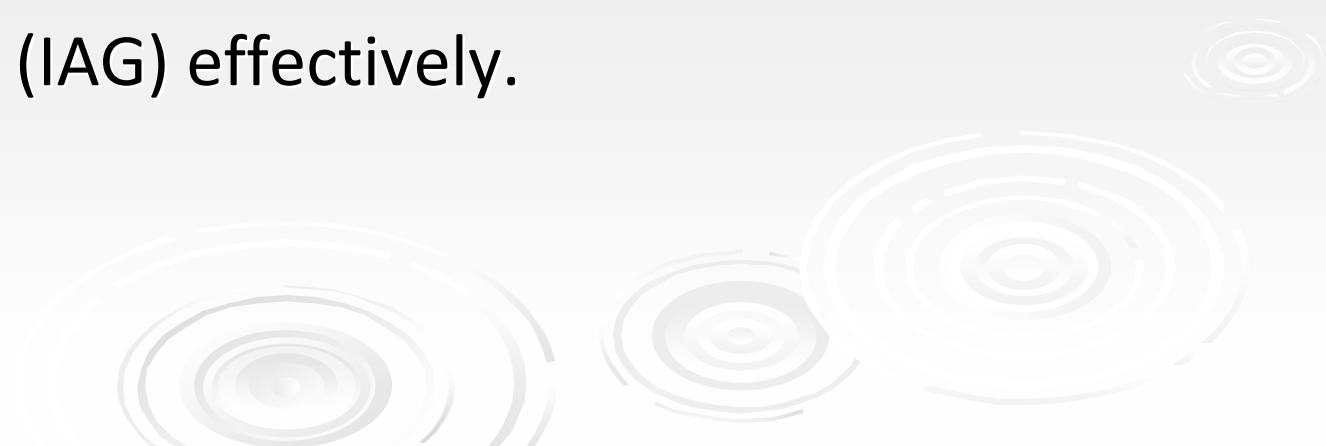
Together they constitute a programme of CEIAG

Careers education for young people

Careers education equips young people to make choices about their future in learning and work and to manage transitions from one stage to the next.

It helps them to use careers information, advice and guidance (IAG) effectively.

Aims of careers education

Through careers education, young people should be able to:

- understand themselves and the influences on them **(SELF DEVELOPMENT)**
- investigate opportunities in learning and work **(CAREER EXPLORATION)**
- make and adjust plans to manage change and transition **(CAREER MANAGEMENT)**



Impartial IAG

- is comprehensive, balanced and unbiased and covers the full range of options available to the young person
- enables individual young people to make their own decisions that are personalised and appropriate to their own situations and needs
- puts the young person's needs first, not those of the institution
- does not make direct or indirect value judgements about any of the options



Statutory requirements on schools

- To provide a programme of careers education for all learners in years 7 – 11
- To provide access to a library of materials “relating to careers education and careers opportunities”
- To co-operate with “careers advisers” (i.e. Connexions PAs)
The Education Act 1997
- To act impartially and in the best interests of the student
- To have regard to guidance that will support the deliver of high quality, impartial careers education
